To be effective, business leaders need reliable, up-to-date financial and operational data both for planning purposes and for budgeting, forecasting, analysis, and statutory and management reporting. They need to be able to integrate corporate and departmental planning, model cost scenarios, and perform sensitivity analysis in order to determine operational budgets based on strategic plans and assumptions. They also need a way to help ensure a fully documented audit trail and compliance with regulatory mandates such as the Sarbanes-Oxley Act for consolidating and reporting company information. Midsize companies face the additional pressure of having to operate with limited IT resources. Hence, they often resort to unmanaged spreadsheets for planning and consolidation, rendering the process chaotic, frustrating, and ineffective. The spreadsheets give them familiar modeling functionalities but lack structured processes and centralized data – resulting in significant time and manual effort throughout the planning process. Budgeting can quickly deteriorate into a "spreadsheet nightmare" in

which operations managers submit unrealistic budgets, executives change figures without the operations managers' knowledge, and version control problems multiply. There is a risk of errors resulting from a lack of checks and balances when entering or updating data. Statutory consolidations can be equally problematic when data is distributed across different departments, systems, and even countries.

The problem is made worse when critical operational and financial information is scattered across multiple applications and databases, or trapped as unstructured data residing in employee spreadsheets or e-mail attachments. Changing to a packaged software solution is usually too complex and expensive to meet the needs of midsize organizations. That's why most of these organizations continue to settle for unmanaged spreadsheets – and to operate at a significant competitive disadvantage.

User Focused

SAP BusinessObjects Edge Planning and Consolidation is designed for ease of use. Features include:

- Native interface to familiar tools Familiar applications such as Microsoft Office, as well as an intuitive, 100% thin-client Web interface, serve as native interfaces to the application. This feature allows, for example, access to Microsoft Excel spreadsheets that are linked directly to "live" operational data; as data is updated in real time, so is the spreadsheet. Working with tools they know well, users need minimal training.
- Intelligent action panes These panes present users with relevant, contextsensitive selections based on where they are in an application and their security profile, enabling them to understand what to do, when to do it, and why – again with minimal training.

Self-service reporting – Any user can access information and create reports without having to make requests to IT. Simple drag-and-drop interfaces enable users to create reports with ease. They can create custom reports or adapt the packaged reporting templates that come with the software to meet your corporate standards. These functionalities are especially helpful to small and midsize organizations that have limited IT resources.

Process Centric

One of the challenges facing finance departments is to ensure that staff and line-of-business managers follow consistent processes across the enterprise. Without the right process support in place, even small deviations can throw off key figures.

Self-service process flows guide users through each step in a process and help ensure that the required steps for a given process, such as closing the books, are completed. Business process flows are automatically tracked and audited. The software comes with prepackaged process flows for common processes, such as quarterly or annual budgeting, that business users can modify without help from IT.

Forward Looking

With a greater understanding of company performance, combined with insight into risk probabilities, you can make better decisions that help manage risk and contribute to future business results.

Business Planning

Planning and Budgeting

You can perform bottom-up and top-down financial and operational planning with a single application and user interface. You can collaborate on plans, manage stakeholder interactions, track versions and changes, engage managers in the planning process, and help ensure clear ownership and accountability. Planning processes are supported by workflows and automation that help ensure that the right people participate at the right time. And you can incorporate unstructured data, such as Microsoft Office documents and e-mail, to help tell the story behind the plans.

The application also supports a streamlined process for preparing budgets that align with strategic plans. A Webbased interface allows widely distributed stakeholders to work together on spreadsheets, both online and offline. And because you start with a single, consistent version of operational and financial data – both real-time and historical – you can have confidence in the integrity and accuracy of your budgets.

Forecasting

Business process flows are tightly linked to the data and processes that support planning and budgeting. What-if modeling and scenario-planning functions enable assessment of budgeting in real time. Additional analytic functionality enables you to produce more accurate plans and budgets, create rolling forecasts, and incorporate real-time actuals with historical data for the most effective forecasting possible.

Reporting and Analysis

You can perform production and management reporting (including exception reports), financial and operational analysis, and multidimensional analysis. In addition, the software helps you compare budget-to-actuals data; automate the intercompany elimination process; gain transparency into corporate transactions at all levels; manage any number of currencies; and perform
